Tennis Court Benches

Pool Umbrellas

A MOTION WAS MADE, SECONDED AND CARRIED to approve the expenditure of \$558.00 to purchase 1 additional umbrella and pole to attach to the existing structure at the pool after color swatch samples have been received.

Proserve Plumbing Proposal

A MOTION WAS MADE, SECONDED AND CARRIED to table the final decision on the toilets until the flooring has been completed.

Caliber Paving Proposal/Inspection

A MOTION WAS MADE, SECONDED AND CARRIED to table a decision on the proposal as the repairs on Sonrisa and Ramada will be done by the Gas Company and the Board would like to have an explanation of why would this street require \$16,860 to petromat overlay, which was not done during the original installation.
